1. Information We Collect

We collect information in the following ways:

A. Information You Provide Directly

Contact Information: Name, email address, phone number, and mailing address when you contact us, sign up for a newsletter, or request information.

Billing Information: Payment information (e.g., credit card details) processed securely via our third-party payment processor, Stripe. We do not store your full credit card details on our servers.

B. Information Collected Automatically

Cookies and Tracking Technologies: We use cookies and similar technologies (like Google Analytics) to improve user experience, analyze site usage, and track marketing campaign effectiveness.

2. How We Use Your Information

We use the information we collect for the following purposes:

To Process Payments: To complete transactions and manage your billing account.
